#### **Biographies:**

**Anne-Marie Jackson** was born and raised in England. She studied languages and worked in the arts. She gained extensive experience as a leader of global justice education and action, working with the Canadian Catholic Organization for Development and Peace as regional facilitator, program coordinator and then director. She led numerous groups on visits and delegations to partners in the Global South. Anne-Marie is currently the executive director of the Jesuit Forum for Social Faith and Justice, based in Toronto.

**Ayon Shahed**, is a strategic leader experienced in the health care, housing, social enterprise, homelessness, and public policy arenas. He is currently the Director of Strategy and Business Development at Seafair Capital in St. John's, NL. Having negotiated numerous innovative partnerships with diverse private, public and non-profit proponents, Ayon understands complex systems and utilizes his expertise to drive ambition, collaboration, and people-centered solutions in all of his work. He has served on a range of local and national boards and committees, including the Canadian Housing and Renewal Association, the St. John's Tool Library and the City of St. John's Affordable Housing Committee. Ayon holds a Masters in Engineering from Queen's University, and in 2015 was named one of Atlantic Canada's Top 50 Under 40. He has previously held leadership positions at Choices for Youth and at Engineers Without Borders Canada.

**Bob McKeon** has recently retired from the Office for Social Justice of the Catholic Archdiocese of Edmonton. Bob has a Ph.D. in theology from St. Michael's College at the University of Toronto. He has taught courses in theology and social ethics for many years at Newman Theological College and St. Joseph's College, University of Alberta. He has been involved for over 30 years in board leadership positions with several community and church organizations. In inner city Edmonton addressing issues of poverty, health, hunger, housing, and community and economic development.

**Devika Shah**, is passionate about building a civic society that is grounded in diversity, equity, social and economic justice, and active democratic engagement. Her interdisciplinary background and experience in the non-profit sector have strengthened her commitment to advancing grassroots, community-led, multi-stakeholder solutions, which she views as the most powerful lever for achieving systems change. She currently serves as the Executive Director of Environment Funders Canada and has previously held positions with Social Planning Toronto, World Wildlife Fund Canada, Pembina Institute, York University and KCI Philanthropy. In these roles, she has strengthened organizational capacity in the areas of civic engagement, strategic integration and planning, fundraising and operations management.

**Sr. Georgette Gregory, CSJ**, as a sister of St Joseph became a registered nurse and nurse practitioner, then developed a healing ministry over thirty years. "My work with the homeless and under-housed in the last twenty years has called me" she has said, "to a deeper spirit of poverty than I ever imagined." She advocated for dental clinics for people who cannot afford dental care (the economically poor as well as the homeless.) As well, she developed and ran a visiting program for people isolated in their homes while working at Mustard Seed. The Fred Victor Mission, (which works for health, income and housing for impoverished and homeless people), has awarded Sr. Georgette its Women with Purpose-Mary Sheffield Award, for a lifetime of leadership in addressing poverty and homelessness in Toronto. Among her many roles, Sr. Georgette has worked to fight human trafficking. As Director of In Good Company, a project of the Toronto Sisters of St. Joseph, she was lauded for her passionate commitment to justice for marginalized people.

**Gladys Yam** is the Director of Finance with The Institute for College Access and Success (TICAS). She is a Chartered Professional Accountant (CPA, CA) with nearly 20 years of experience in the accounting and finance fields, having spent 10 years with Ernst & Young and then nine years in the higher education and non-profit industries at the University of North Carolina, Jobs for the Future, and TICAS. She earned a BMath and a Master of Accounting (MAcc) from University of Waterloo and an EdM from Harvard Graduate School of Education. She has also earned a Diploma of Christian Studies from the Tyndale Seminary in Toronto.

**Sr. Jean Gove, CSJ,** is a resident of Toronto whose background includes high school teaching and campus ministry. She has a doctorate in English, specializing in Canadian literature. She served on the Sisters of St. Joseph Leadership Team with various administrative responsibilities for two successive four-year terms, then in financial management for nine years with the Pontifical Mission Societies. She has served on several hospital boards and most recently that of Fontbonne Ministries. One area that has been of particular interest and continues to be a focus is that of socially responsible investing.

**Kelly Holmes** is a long-time advocate and youth homelessness change-maker. As Executive Director at the Winnipeg street-level, non-profit agency, Resource Assistance for Youth, Inc., Kelly's focus is on the design and delivery of innovative youth-centered programming that meets the needs of Winnipeg youth, on their terms. Nationally, Kelly is a well-known thought leader on the subject of youth homelessness, sitting on numerous advisory boards and has contributed to improved social policy that better supports young people. In 2014, Kelly was the catalyst behind Here and Now: The Winnipeg Plan to End Youth Homelessness, rallying immense local and national support for the Plan. Kelly is committed to holding space for young people to find their own power.

**Larry Murray** is a retired partner of KPMG and spent his entire professional career in the public accountancy field, specializing in income tax, including the tax treatment of registered charities and other not-for-profit entities. In addition to being a professional advisor to registered charities, he has been a volunteer in the sector throughout his career.
